Dear Subscription Agency Representatives,

In order to avoid a substantial increase to our subscription rates, the ASPT officers and Council members unbundled the online access and print copy for subscriptions starting with *Systematic Botany* vol. 40 (2015).

The current ASPT Council has decided that there will be no rate increase for the 2020 basic subscriptions. A subscription at the 2020 base rate is for an online only subscription. If a subscriber would also like to receive a print copy of *Systematic Botany* for 2020, volume 45, the print version may be purchased for an additional cost of \$65/volume for delivery to addresses in the U.S. and \$85/volume for delivery to addresses outside the U.S. The charge for the print copy is an "at cost" production and postage price using digital printing to replace offset printing. The digital print product at The Sheridan Press is high quality, and their pricing is highly competitive.

Individual, electronic pro forma invoices for current *Systematic Botany* subscribers should be distributed in November. If you need an immediate invoice for a renewal or would like to request an invoice for a new subscriber, please send your request to aspt@uwyo.edu.

The list includes all lower, lower-middle, and upper-middle economies as determined by the World Bank. The list also includes 24 high-income economies, each with a GNI of less than \$22,000.

The cost for a 2020, Developing Country individual membership (with online access to Systematic Botany) is \$30.00 and a basic institutional subscription to Systematic Botany at the Developing Country rate (online only access, no print copy) is \$90.00.

ASPT Policy Statement for Systematic Botany Subscriptions

Access to online content: For the years that a subscriber has paid, it is our intention to maintain availability of the *Systematic Botany* volumes to the subscriber.

Years of access included in the subscription: At IngentaConnect, a subscriber is granted access to *Systematic Botany* from vol. 29 through the volume of the final, paid subscription year.

Activation of online subscription at IngentaConnect: Subscribers register at IngentaConnect and submit an activation request for *Systematic Botany*. Specific instructions are available from ASPT Business Office at aspt@uwyo.edu.

The URL for institutional subscribers is https://www.ingentaconnect.com/register/institutional ASPT members will use this link https://www.ingentaconnect.com/register/personal

Each subscriber or subscribing institution is assigned a *Systematic Botany* Subscription Reference Number (SRN). The SRN is required information when submitting the *Systematic Botany* activation request at Ingenta. The SRN remains with the subscriber, even if the subscriber changes subscription agencies or a subscription lapses for a period of time.

The subscriber is only responsible for the initial activation. When a renewal payment from the subscriber is processed, the ASPT Business Office sends the updated information to Ingenta for the new subscription year.

Site license for institutional access: At this time, a site license is not required.

Site definition: Generally a site is an institution with a single campus or location. In some cases an institution may have multiple campuses, but it is a single institution, in which case we would regard this as a single site. The site definition for an institution may be evaluated individually on a case-by-case basis.

Data Storage: Downloading content for storage is allowed. Downloading for the purpose of dissemination is not allowed.

IP Information for Institutions: Institutional subscribers may use IP authentication, and proxy authentication is allowed. Remote IP authentication through login for an institution's students, staff, and faculty is allowed. To update the IP information in an account, the administrator needs to login to the subscription at IngentaConnect and edit the IP information in the profile.

Usage statistics at IngentaConnect: To access the data, follow these instructions:

- 1. Login to www.ingentaconnect.com with the administrator username/password
- 2. If not redirected, please select the link on the right to "Administration"
- 3. From the "Administration" page scroll down to the heading "Collections". The links to the usage statistics can be found under there.

Shipping Schedule for Print Copies: *Systematic Botany* is shipped on a quarterly schedule, Jan-Mar, Apr-June, July-Sept, and Oct-Dec.

Claims: No special form is required for claims. Claims for undelivered or damaged print copies of *Systematic Botany* must be submitted within one year from the issue publication date. Claims may be submitted by email to Linda Brown at aspt@uwyo.edu .

Cancellations: Subscriptions may be cancelled at the beginning of the subscription year (by January 15) or at the end of the subscription year. The subscription year ends on December 31.

Refunds: A refund will be issued to a subscriber if the cancellation and refund requests are received at the ASPT Business Office by January 15 of the subscription year.
